President's Report:

At the August 27, 1999, Executive Council meeting, President Sarcevic reported that the Society is in stable financial condition; we have been called upon by a number of prestigious institutional agencies for support (such as United Nations agencies, The Hague Conference, etc.). He reported that since the last Executive Council meeting we have had two regional conferences, one in Prague for Central and Eastern Europe, and one in Albuquerque, New Mexico for North America. Also, the ISFL is increasingly invited to consult with major international bodies.

At the request of President Sarcevic the ISFL will send UNESCO and its Commission on Human Genome Project the papers presented at our Oxford Conference on Biomedicine, Human Rights and Family Law.

Also, at the suggestion of President Sarcevic members of the ISFL who have belonged to the Society for more than 25 years, as well as others who have rendered distinguished service to the Society, will be honored at the Tenth World Conference in Brisbane. (*Ed. -We ask all members to notify President Sarcevic or the Secretary-General of names of persons to be considered for inclusion in the list of honorees.*)

Secretary General's Letter:

I am pleased to report that the California Western Law School Journal of International Law has agreed to publish a symposium issue next year (2000) containing papers presented at the Prague conference (offering a chance for publication for all papers—some may need to be revised before they can be included). I also am pleased to inform the members of the Society that the Executive Council has voted unanimously to co-opt John Dewar and Stephen Parker, co-convenors of the Tenth World Conference in Brisbane, Australia, to membership in the Executive Council to serve until the next election.

Two separate proposals have been made to host the Eleventh World Conference of the ISFL (in either 2002 or 2003). A proposal for a world conference in Salt Lake City, Utah, has been made by a member, including letters from the mayor of Salt Lake City and the Salt Lake City Convention Bureau. The conference would follow the 2002 Winter Olympic Games in Salt Lake City. Linda Nelsen and Peter Lødrup have proposed that the next conference convene in Copenhagen and Oslo, starting with sessions held for a day or two in Copenhagen; then conferees would take a boat trip overnight to Oslo, and convene the next session in Oslo. Your input about where and when you would prefer to have the next world conference (after 2000 in Brisbane) is welcome. Contact any member of the Executive Council (names and addresses are in the membership booklet and on the Society's website listed below). *The Executive Council would welcome any additional proposals to host either a World Conference or a Regional Conference of the Society.* Persons interested in making proposals may contact the Secretary-General (or any other member of the Executive Council) to have the proposal raised at the next Executive Council meeting.

Report of the Editor of the Annual International Survey:

At the August 29, 1999, Executive Council meeting, the Editor of the Annual International Survey, Dr. Andrew Bainham, reported, inter alia: "The Society has now produced four volumes of the International Survey. Each has contained just over 30 articles. The latest to appear is the 1997 Survey which was published in May of this year. I am happy to report that the editorial work on the 1998 Survey is well advanced. I have received thus far 26 contributions and it is certain that several others will shortly arrive. I expect to be

in a position to deliver the manuscript to the publishers by early October which ought to result in publication fairly early in 2000. So far as coverage is concerned, every Survey, including the one in preparation, has included pieces from every continent and, again, I am pleased to report that this will also be true of the 1998 volume. Forthcoming 'highlights' include the first ever Palestinian contribution, the re-emergence of France (last included in the 1994 Survey) and the reappearance of Papua New Guinea which was last included in the former Annual Survey. That will continue." He noted, however, that the publisher, Kluwer, has raised the price of publication for the paperback issue twice and now wants to raise it again. With approval of the Executive Council, Dr. Bainham will explore possible alternative publishers.

Reports on Recent Conferences:

Oxford Biomedical-Family Law Conference. Ruth Deech hosted and co-convened with Marie-Therese Meulders Klein a very successful International Conference on Biomedicine, the Family, and Human Rights at St. Anne's College, Oxford, 27-30 August 1999. The conference attracted 125 delegates from 29 countries around the world. The proceedings began Friday evening in perfect late-summer weather with a lovely outdoor reception under a canopy on the lawn at St. Anne's College. Sessions on Saturday and Sunday featured some of the most knowledgeable world authorities on issues arising at the intersection of biomedical, family and human rights law, especially from Europe. The conference gave participants the chance to hear from some of those experts, and provided many excellent opportunities for participants to get acquainted with and discuss the issues with them and with each other. In addition to general speeches from such delightful presenters as Professor Christine Gosden and representatives of the Council of Europe, major sessions explored implications of new artificial reproduction technology for family law, ethics, and medical practice, and the implications of evolving genetic procedures for issues of parentage, patient consent, confidentiality, responsibility, privacy and family life. A lovely closing banquet was held Sunday evening at Wadham College. Kluwer will publish the proceedings of the conference. The Secretary-General also has agreed to publish the papers of the biomedical conference on the ISFL website when the convenors provide them to him.

Albuquerque Conference on Unions. Professors Sherri Wolf and Alan Parkman (University of New Mexico) co-hosted a very successful North America Regional Conference at Albuquerque, New Mexico, June 10-12, 1999. Nearly 60 members of the Society attended. The conference topic was *A More Perfect Union? Marriage and Marriage-Like Relationships in Family Law*. Panels addressed such topics as Domestic Partnership, Children of Marriage-Like Relationships; Custodial and Visitation Issues in Non-traditional Families; Step-families; Support Issues for Partners and Children; Theoretical Perspectives on Marriage and Marriage-Like Relationships, and Interjurisdictional Issues Concerning Marriage-Like Relationships. Small break-out sessions provided for excellent discussions. A keynote address delivered by Judge Ferguson of the Navajo courts, describing family relations and family law among the Native Americans in the southwest was particularly fascinating. The papers were a very good quality. The New Mexico Law Review (and the secretary general notes the BYU Journal of Public Law and the Canadian Journal of Family Law) agreed to consider papers for publication. The meetings were held in the Sheraton Old Town Hotel, across from the delightfully restored "Old Town" "Pueblo Santa Fe" which provided a wonderful area for attendees to walk, talk, visit, shop, and explore the Spanish Mission era theme sights and stores in the wonderful weather of the American southwest. Eighteen (18) new members joined (or resubscribed to) the Society during the conference. Margo Melli, Lynn Wardle, Sanford Katz, Don MacDougall, Nick Bala, Nancy Polikoff, and Marsha Garrison helped Professors Wolf and Parkman organize the successful conference.
