#### MESSAGE OF THE PRESIDENT:

REPORT FROM THE CONVENORS PROFESSORS LINDA NIELSEN, COPENHAGEN, AND AND PETER LØDRUP, OSLO.

#### I. General.

- 1. The Council of The International Society of Family Law decided in 2000 to hold its 11th International Conference in Copenhagen and Oslo. The topic of the conference was "Human Rights and Family Law" with subsections:
- "The Significance of International Conventions regarding Family Life"
- "Family Life and State Intervention"
- "The Right to family Life Family Reunification"
- "Human Rights and the Equality Within the Family"
- "Children's Rights International Conventions""
- " Family Rights and Biotechnology
- 2. The Conference took place from August 2 until August 7. Transportation from Copenhagen to Oslo took place during the night between August 4 and 5 on the 1500 passengers liner "Pearl of Scandinavia".
- 3. The venue in Copenhagen was the Main Building, University of Copenhagen and in Oslo The Libraray Building at Blindern, University of Oslo.
- 4. Conference fee was DKK 4000 (appr. \$ 533) for members and DKK 4500 for non-members. The fee included reception August 2nd, lunch and dinner at the Tivoli Restaurant Nimb August 3rd, the boat ticket with buffet and breakfeast (value appr. \$ 180), sightseeing and lunch in Oslo August 5, lunch and dinner August 6, lunch and reception in Oslo City Hall August 7.

Free tickets to and from the conference venue and the hotell area was offered

Free copying and IT facilities were offered.

In the main auditorium there were simultanous translations English/French and French/English.

#### 2. Participants and Speakers.

The conference was opened by Professor and Rector of the University of Copenhagen Linda Nielsen. In Oslo the conference was welcomed by the Minister of Children and Family Affairs Laila Dåvøy.

Two hundred seventy-six participants from 45 countries were registered participants. There were five main speakers and 119 participants presented papers and held introductions between 15 and 25 minutes.

Eleven papers were presented at a poster sssion.

A Handbook with the final program, abstracts of the papers and the names and addresses of the participants was distributed. Some participants registered after the handbook was printed.

Due to generous grants from NORAD and the Ministry of Foreign Affairs, the convenors were able to support financially 15 participants from mainly Africa and Asia.

#### 3. Financial matters.

The conference was financed by conference fees and sponsors.

### 4. Publication of a selection of the conference papers.

About 50 of the papers will be published in a separate book (bound). The selection is based upon the quality of the papers, geographical considerations and a thematic balance. The book

will be of about 900 pages. Free copies will be sent all members of the ISFL and the non-member participants whose papers are published.

### REPORT OF THE SECRETARY-GENERAL:

The Executive Council of the Society met in Paris in February 2003 and discussed a large number of items. Of particular note was the planning of several regional conferences of the Society which will take place on three continents during 2003 - the regular North American conference to be held in June in Portland, Oregon, the first ever conference of the Society to be held in China, in July in Beijing, and two conferences in Europe in the autumn - at Tossa de Mar, Catalonia, Spain in October, and Lyon, France in November. This range and scale of conference activity appears to demonstrate very clearly the current vigour of the Society and the enthusiasm of its members. The Council also discussed the outcomes of the past two world conferences of the Society - the book of the Brisbane conference proceedings, to be published by Hart Publishing, Oxford, UK, is due to appear imminently, and preparations are well in hand for the publication of papers from the Copenhagen/Oslo conference last summer. The Council congratulated the convenors on their efforts in bringing these conferences to successful conclusions, and it also received a presentation from its immediate past President, Prof Lynn Wardle on the arrangements he is making as convenor of the 2005 conference to be held in Salt Lake City, Utah, USA.

As ever, the Council is keen to encourage family law scholars to take advantage of these sorts of academic activity. In a previous newsletter, I gave details of the Council's decision to send, with the generous support of its publisher, Jordan Publishing, complimentary copies International Survey of Family Law to law schools that would otherwise be unable to bear the cost of buying the volume or meeting the subscription for a Faculty member to join the Society. Thanks to the support of Tilburg University, our Treasurer, Prof Paul Vlaardingerbroek, is able to send some copies to additional law schools and would welcome members' suggestions for institutions that should be included. Divorce: Causes and Consequences

The International Society of Family Law (ISFL) is pleased to announce that it is

sponsoring a Regional Conference in Beijing, China, on July 21-24, 2003. Wu Chang Zhen, Professor Xia Yinlan, and Professor Yang Quinho, from the China University of Political Science and Law in Beijing are collaborating with Professor Lynn D. Wardle of the ISFL and Brigham Young University in planning and hosting the conference. Chinese family law professors, lawyers, and government officials will be participating in the conference. There will be translation services. We invite interested academics and professionals (including judges and other government officials) to submit proposals to present papers at the conference, or to just register to attend the conference.

- 1. Conference Theme: "Divorce: Causes and Consequences." (Specific subjects may include comparative divorce, legal principles, rules, procedures, practices, issues, and problems in divorce regulation and administration, and the causes and effects of divorce.)
- 2. The conference meetings, meals and lodging are in the State Guest Hotel, a five-star hotel in Beijing.
- 3. Lodging: All participants must make their own hotel reservations, pay for their own lodging. A
- 5. The registration fee for all non-Chinese participants including all presenters will be about 462US\$. This consists of two main expenses: (a) The general registration fees is 282US\$ which covers site and other expenses including the paper book (each participant will get one papers collection before the conference), meeting facility, equipment, copying, supplies, conference meals, field trips and sightseeing, transportation. (b) The translation fee for translating all the papers from Chinese to English or from English to Chinese, simultaneous interpreters, rent for the equipment of simultaneous interpretation, etc., is 180US\$. So, the total registration fee of one participant will be 462US\$, not including the lodging fee. Accompanying persons will pay a fee of about 125 US\$ to cover the evening meals/ banquet and the field trip and sightseeing trip.
- 6. The conference registration fee would include lunch and/or dinner on all conference days. The hotel registration fee would include breakfast every day following a night in the hotel.

The Role of Self-Determination in the Modernisation of Family Law in Europe, to beheld in Tossa de Mar (Catalonia, Spain), October 9 and 10, 2003

Tossa de Mar is a small village on the Spanish Costa Brava, which is 100 Km north of Barcelona and approx. 100 Km south of the French border. Closest airports: Barcelona airport and also Girona-Costa Brava airport (much smaller, with less traffic, but very cheap flights).

# "Child abductions across international boundaries" University Lyon 3, Jean Moulin, 20/21 November 2003

Frequently, the different drama following the separation of couples are picked up by current developments, when children become the stakes and the victims of the dispute between their father and mother. The

international dimension of the dispute make the issue more complicated when the borders are used by parents as a weapon, even if they think acting for the children interest.

To fight against this curse, several international instruments from various source and scope appeared. Two of them are specifically devoted to this question: the Hague Convention of October, 25<sup>th</sup> 1980 on the Civil Aspects of International Child Abduction, and the European convention of May, 20<sup>th</sup> 1980 on recognition and enforcement of decisions concerning custody of children and on restoration of custody of children.

This two instruments seek to protect the right of custody by providing a procedure allowing a prompt return of the children in his usual residence country, and the protection of the right of access, which is the consequence of the right of custody. These conventions were signed in 1980. They entered into force in France in 1983.

Following the report "Familial conflict, children abduction and judicial cooperation in Europe", made by the Family law research centre (University Jean Moulin Lyon 3) on the request of the French Ministry of Justice and
