MESSAGE OF THE PRESIDENT:

The Executive Council of the ISFL met in Modena in March 2006. We had a good meeting and afterwards a wonderful Italian/Toscanian dinner, that our colleague prof. Maria Donata Panforti offered us. We discussed many issues, among which the co-option of new council members (Prof. Velina Todorova from Bulgaria, Prof. Noor Aziah Md Awal from Malaysia and Prof. David Bradley from the UK), the next International conference to be held in Vienna (the convenor is Prof. Bea Verschraegen), the next regional conferences, among them the one in Chester in July 2007 (convenor is Prof. Roger r.kay@chester.ac.uk) and many other issues. The secretary-general will tell you more about that in her message.

We owe Dr. Andrew Bainham many thanks on behalf of not only all ISFL-members, but also on behalf of all who do comparative research and read the International Survey of Family Law. For many years he has done a great job by editing this book. Those of us who have edited a book before, know how extremely difficult it is to collect all the contributions and to standardize them. Andrew has done this for more than 10 years. In this case Andrew had to cooperate with many contributors all over the world and he had to spread the contributions over as many countries and continents as possible. Andrew, it is really great what you have done for ISFL and its members. I know that some criticize the book: it should more focus on themes and it should be written in French too, but to my opinion it is a great gift to our members to receive such a rich book every We may not forget how important the International Survey is for the work of ISFL. More than 3/4 of the Society's income is spent on the Survey, which is sent to all the members of the Society free of Therefore, it is necessary to keep the expenditures of ISFL as low as possible and to collect all the subscriptions. So, please help the treasurer by paying at his request and to keep your address at the member ship list updated. With regard to the treasury, I am glad to announce that we succeeded in finding a new treasurer. As you may know I was the treasurer of ISFL since the Opatija Conference in 1991, organized by Prof. Dr. Petar Sarcevic, who died so suddenly. The combination of two functions was too much, so we tried to find a successor. Fortunately, we found Ad van der Linden willing to become the new treasurer. He will also keep the membership list updated.

The question arises if our Society should still be satisfied with a membership of about 550. I think that each of us should try to increase the number of members from certain European countries, especially from Eastern Europe and from Asia, Africa and Central and South America. If you know people who might be interested in ISFL, please mention them to me or contact them your self.

I wish you a lot of success in your work and much happiness in your family and private life.

REPORT OF THE SECRETARY-GENERAL:

Dear Colleagues:

The Executive Council has recently undertaken two new policy-making initiatives. A subcommittee on cooptions (M. Antokolskaia, C. Bruch, O. Dyuzheva, B. Verschraegen, P. Vlaardingerbroek) is drafting guidelines on the co-option of new Council members. The Society's by-laws require that the Executive Council should reflect the Society's international character to the extent possible and give the Executive Council the power to appoint members "as it may deem necessary or desirable." The Council has historically used its co-option power to add members from

geographically under-represented areas and with special expertise. The co-options subcommittee will consider procedures for identifying individual co-option candidates and the special problems of ensuring African, Asian, and Latin American representation on the Council.

Another new subcommittee (C. Bruch, M. Casals Martin, M. Garrison, P. Parkinson, P. Vlaardingerbroek, L. Wardle) is looking into problems associated with conferences convened in nations with policies that discriminate based on race, religion, or national origin. The subcommittee will draft principles to guide the selection of ISFL conference venues and criteria for advertising non-ISFL conferences in the Society's newsletter and on its website.

Both of these subcommittees will report to the Executive Council at its next meeting on April 14, 2007. If you have thoughts on either of these policy-making initiatives that you would like the relevant subcommittee to consider, please communicate with one of its members soon.

Some time during the next few months, a volume of papers from the Society's very successful 2005 World Conference in Salt Lake City, Utah will become available. The volume, approximately 800 pages, contains a wide range of Conference papers. Its projected cost is \$72 for ISFL members and \$80 for nonmembers.

Planning is also underway for the Society's next World Conference in Vienna, Austria on July 22-26, 2008. The conference will focus on "Family Law and Family Finance." A link to the conference site is already available on the ISFL's website, and as more detailed information about the social and scientific program for the conference becomes available, it will be posted there.

The ISFL's website also has several new features. First, the site now has a "secure" portion which contains the International Survey. This new feature, which requires a user name and password, offers all Society members the opportunity to access the Survey electronically. Second, the English and Spanish-language versions of the site are now linked. By clicking a language-choice button, a visitor may access news about the Society in either language. These sites are not identical; each includes news and announcements of special interest to their readership. Planning is also underway for a

Russian-language version of the ISFL website that will also include area-specific content.

No matter what language you elect to read it in, the Society's website will continue to provide information about ISFL publications, conferences and news, and well as other conferences of interest to our members. It is worth checking the site from time to time to see what's new.

NOTICE AND CALL FOR PAPERS:

A Symposium on "Children's Rights and Adoption" is scheduled to convene on Friday, March 2, 2007, at the J. Reuben Clark Law School at Brigham Young University. The topic is intended to be broad, to allow prospective presenters to develop a topic relating to adoption law that they are interested in, perhaps working on already. Presentations already scheduled to be included will address proposed revisions to the ICPC, the new US rules regulating International Adoption, and narratives about children's concerns about lesbigay adoption. Law school and related

faculty and professional are invited to attend and to propose papers for presentation. The nominal registration costs (\$50 - to cover food, snacks, materials, etc.) will be waived for persons selected to present their papers. Persons interested in presenting should send a one-page abstract containing their name, institutional identification, contact information, a "working title" and a 1-or-2 paragraph description of the paper they propose to present. Proposals should be sent to Professor Lynn D. Wardle, BYU Law School, via email at lynn wardle@byu.edu before November 30, 2006. The symposium papers should range from approximately 10,000 - 20,000 words in length, drafts must be submitted electronically at least 3 days before the symposium for website posting, and final versions of the papers must be submitted for publication four weeks after the symposium. We expect to arrange for publication of the timely-submitted papers in a law journal mini-symposium issue.

The CEFL's third conference is centered on four themes currently at the forefront of policy debate and academic discussion. The harmonization of family law in Europe, in particular in the Nordic countries, and the USA forms the basis for the first general theme. The second core topic of discussion will be the rights of children and the responsibilities owed to them. Papers will also be presented on the recent developments in cross-border family matters and finally the position of cohabitants upon the termination of their relationship either by means of death or dissolution will be addressed. This last topic has also been chosen as CEFL's third working field.

At the previous two CEFL conferences which took place in 2002 and 2004 particular attention was paid to the methodological aspects of the development of a European family law. In this context the first Principles in the field of divorce and maintenance between former spouses were discussed. At the third CEFL conference the second set of Principles regarding parental responsibilities will be presented.
