#### **MESSAGE OF THE PRESIDENT:**

Dear colleague, dear friend,

About one month ago we had a very interesting meeting, organized by our dear colleague, Hugues Fulchiron, who is now president of the University in Lyon. The theme was the dissolution of non-married couples. Together with the council members, French colleagues and students we had a very interesting day at the University of Lyon. For those who have never been in Lyon, you must know that this city is called a second Paris. Two lovely rivers, an old inner city, nice restaurants ... Fortunately we had good weather, although the conference took the whole day. One very interesting thing was that you can see how quickly developments have gone in the last decades. Only 30 years ago, it was very unusual to start living together instead of marrying, although in some countries these developments (probably some would not speak of 'developments' but 'facts') have gone further than in other countries. World wide we now have a wide variety of relationships: marriages (hetero- or homosexual), registered partnerships, and other living arrangements, although in many countries the marriage is still the only living arrangements that is fully accepted. Nevertheless, those who live together without good arrangements are usually hardly protected by law. We discussed the legal consequences (no alimony, no pension, no community of goods, and what about the children?) of this and whether the legislator should protect the persons who are confronted with the dissolution of their relationship and who have not made an arrangement before the notary or solicitor or who do not even have a self made contract.

You can imagine that we had an inspiring day, thanks to the convener of this mini conference and our host for the council meeting, Hugues Fulchiron. Together with the very good French food and the other festivities he had organized for us, we had a very good combination of intellectual work with delightful entertainment.

We also discussed several other issues in Lyon. One of them is that we sincerely hope that you will come to Vienna in September this year, although in some countries the semester had already started. Probably you can ask a good colleague to give your lectures in that week, but please come. Bea Verschraegen, the convener of this 13th World Conference has made a good program on the interesting subject, "Family Finances". This theme has been dealt with more than 20 years ago by the convener of the conference in Brussels ( Belgium), Marie-Thérèse Meulders-Klein (The Family, the State and Individual Security), but in 23 years the whole world has changed and financial questions within families and in Family Law are still very hot. So, we think that this theme will attract many colleagues to Vienna, a very beautiful town in Austria. Please come!

In Lyon we also discussed the financial situation of the council. Since the costs of the banks have increased and many members pay too late or forget to pay the extra costs of the cheques they send, we have to increase the cost of dues. At the next council meeting we will discuss the issue. I still think that the actual subscription is very low for what members get: being member of an outstanding group of academics and practitioners in Family Law, each year a very interesting International Survey of Family Law (now edited by Bill Atkin, before by Andrew Bainham), the Family Letter twice a year (edited by Margaret Brinig) an interesting discount for international and regional conferences and a forum for international debate with colleagues in the same interesting field of Family Law! So, please understand that the dues for membership will be increased.

Together with some other members of ISFL we had an interesting working group at the conference in Kapaonik, Serbia, which working group was organized by our colleague Olga Cvecic-Jansic. We had lots of snow in this ski resort in the South of Serbia, but warm discussions on several problems in the field of Family

Law.

For myself, this is the last half year of my presidency. In Vienna I will give you my final remarks to what has happened in the last three years, but I can mention already that I think we have a very good society of interested scholars with offers a lot for its members. Nevertheless, we should work on more: attract more members from Central and South America, from the Middle East, from South East Asia, from North and Central Africa and from the developing countries. I tried to work on that, but I found that if we do not have possibilities to financially support people from those developing countries it is very hard to increase the number of members. The new president will start in September this year and I think this issue will also be one of the great tasks for him or her.

I hope that – with your help – we can build further on our Society of Family Law and for a better world in which families and family members feel save and happy. Family lawyers, academics and scientists in the field of Family law can contribute a lot to help children and family members in vulnerable positions and to make a plea for better statutes and regulations in this field. So, please find new members in your own country or elsewhere.

However, it is not only the growth of our Society in the number of members, but I think we will grow in importance too. International organizations, legislators and politicians must know that our Society can offer them a great number of academics and a lot of knowledge in the field of Family Law and Family Life. Promoting the scientific exchange of ideas is one of the important goals of ISFL.

#### REPORT OF THE SECRETARY-GENERAL:

Dear Colleagues:

The Society's Executive Council met in March 29, 2008, in Lyon, France. The meeting was held in conjunction with a symposium on The Nonmarital

Family sponsored by the Family Law Institute of the University of Lyon and planned by Executive Council member and meeting host Professor Hugues Fulchiron.

At its meeting, the Council approved plans for a regional conference in Israel to be held in June, 2009. The conference, on the theme, "Civil and Religious Law in Family Matters: Family Law in a Multicultural Environment," will take place at the Sha-arei Mishpat Law College and Bar-Ilan University School of Law. Conference convenors are Dr. Shahar Lifshitz of Bar-Ilan and Professor Rhona Schuz of Sha-arei Mishpat.

The Council also began to consider the venue for the 2011 World Conference, which will be selected at Executive Council meetings held in conjunction with the Society's next World Conference in Vienna this September. Should you wish to make a proposal to host the conference or wish more information about making such a proposal, please contact me as soon as possible. The Council is particularly interested in receiving proposals to hold the conference outside of Europe given that Europe is the location of this year's conference.

At the Vienna World Conference, the Society will elect officers and Executive Council members. To be placed on the ballot as a candidate for membership in the Executive Council requires nomination by two members of the Society. The nominee must also signify his or her approval to the nomination in a letter signed by the nominating members and received not later than 60 days before the General Meeting. Any five members of the Society may nominate a member to be an officer; again, the nominee must signify his or her approval to the nomination in a letter signed by the nominating members and received not later than 60 days before the General Meeting. Each candidate has the right to submit a statement of 200 words or less. Given the timing of this year's General Meeting, I need to receive all nominations and any statement a candidate wishes to submit on or before Friday, July 19.

### REPORT ON THE INTERNATIONAL SURVEY OF FAMILY LAW

This year has produced a bumper crop of papers. This is the result of hard work on the part of a lot of people, including members of the Executive Council – thank you. It also means a lot of editing!

I have chapters from Australia, England, Finland, France, Germany, India, Israel, Italy, Japan, Korea, the Netherlands, New Zealand, Samoa, Puerto Rico, Serbia, Sierra Leone, Slovenia, South Africa, Spain, Sweden, Switzerland, Turkey and the United States. I have some other firm promises still to come. There is still an over-representation by Europe and nothing from Latin America apart from a short piece from Puerto Rico. I am still struggling with this one.

An issue that I mentioned in my report to the Barcelona meeting is that of refereeing. I do not believe that the Survey should be turned into a fully refereed publication or anything like that, but requests for papers to be reviewed will, I suspect, continue as the policies of various governments require quality assurance. I would like to accommodate requests if at all possible. With respect to the 2008 edition I have had two papers read by New Zealand colleagues and I am grateful to them for this. It is in my mind that this is a task that I may call on Council members to do – on a very occasional basis.

For the 2008 edition, I have used Peter Schofield to translate one chapter into English, and Dominique Goubau has done a grand job translating the résumés. There are still several of these to arrive from authors.

#### REPORTS ON CONFERENCES:

### New Family Maintenance Convention Approved in The Hague

At its Twenty-first Diplomatic Session, the Hague Conference on Private International Law approved the new *Convention on the International Recovery of Child Support and Other Forms of Family Maintenance*. The Final Act containing both the new Convention and a *Protocol on the Law Applicable to Maintenance Obligations* was signed on November 23, 2007, by delegates from 68 states and the European Community. At the conclusion of the Diplomatic Session, the Convention was signed by the United States, indicating its intention to proceed toward ratification.

The Convention and Protocol were the product of prolonged and complex negotiations that began in 2003. Building on several previous Hague conventions and the 1956 New York Convention on the Recovery Abroad of Maintenance, the new Convention is intended to provide a more prompt, accessible and cost-effective system for support enforcement across international borders. It mandates that all contracting States provide effective access to procedures, including legal assistance where necessary to achieve recognition and enforcement of a foreign child support orders. Various Working Groups and subcommittees devoted many hours to developing procedures to simplify the international enforcement process and facilitate cooperation between contracting States, including standard forms, an eletronic system of country profiles, and timelines for case processing.

Many ISFL members participated in the work of developing the new Convention over more than five years. At the final sessions, Linda Elrod and I were also present as Observers on behalf of the ISFL. The text of the Maintenance Convention and the Protocol are available on the web site of the Hague conference at www.hcch.net.

Gender, Family Responsibility and Legal Change

An international, interdisciplinary conference

#### 10 – 12 July 2008 Brighton, East Sussex, UK

Because societies are changing a number of issues in family law are currently on the political and legal reform agenda in many countries — unmarried cohabitation, divorce, income and property on divorce, contact with children, residence of children, father's rights, assisted reproduction, the criminalisation of family antisocial behaviour (with a particular focus on children), the welfare test in the aftermath of the advent of legally enforceable individual rights, and many others.

Even outside the bounds of traditional family law there are numerous issues that have implications for families and family responsibilities — balancing the roles of mothers and fathers in the labour market and in family life, support for the elderly and responsibility for pension provision, the protective role of family members in the face of dramatic environmental changes, and others — which see family membership as the source of political engagement.

In each of these reform movements gender looms large as the issue that makes resolution either particularly difficult or especially interesting (and certainly politically contentious).

In this conference – which will draw together people working in a variety of spheres of both political and academic life – we wish to consider the role that gender plays in determining family responsibility and in debating and achieving legal change. We hope to see it examine questions that range across social life in every part of the world. Questions which we hope to see addressed and explored include:

- What is family responsibility?
- How is family responsibility gendered?
- When is the law implicated in questions of family responsibility?
- Is the involvement or absence of law in the family gendered?
- What responsibility does law have for the family?
- What is the role of the state in relation to family responsibility?
- How does (and should) law and lawyers interact with other disciplines in resolving questions of family responsibility?

the University of Sussex, close to the seaside city of Brighton and Hove and the South Downs, between 10 and 12 July 2008.
