The preparation of the book on the 13th World Conference, which took place in Vienna last year, is making excellent progress. Half of the authors already received the first print; the others will receive it within the next 3 or 4 weeks. I hope to have the book published by July 2009.

REPORT OF THE SECRETARY-GENERAL:

At its annual meeting, held in February, 2009, the Executive Council chose the theme and venue for the next world conference, to be held in 2011. The conference will be convened by Professor Hugues Fulchiron at the University of Lyon in Lyon, France. The theme will be "Solidarity Among Generations." A date for the conference has not yet been set, but we are hoping to be able to announce one in the fall newsletter.

The Council also approved various regional conferences and symposia. In addition to the

Israeli conference, described elsewhere in this newsletter, a regional conference or symposium is scheduled in Brazil and Japan. The Brazilian conference will take place on August 27-29, 2009, at McKenzie University in Sao Paolo, Brazil. The conference will take place in connection with the annual meeting of the Institute Brasileiro de Direito de Familia (IBDFam), and the conference theme is "Children's Rights." The Japanese symposium will take place in late 2010. The theme will be "Reconstruction of Modern Families: Recent Developments in Asian Law." symposium, invited speakers will discuss the impact of natural and manmade disasters, such as earthquakes and war, on the family. Information on these regional meetings and the Israeli conference is available now, or will soon be available, at the Society's website.

The Council also approved various amendments to the Society's by-laws. These amendments would:

1) make the Society Newsletter Editor an appointive member of the Executive Council;

The Editor of the International Survey is an appointive Council position because this important job requires regular reports to the Executive Council and continuity in the editorial function. Because the same concerns apply to the Newsletter Editor, the Council felt that these two positions should be treated in the same way.

2) create a new Council membership category based on past service;

The Society's Executive Council needs members with leadership experience, but it

also would profit from the election of young Society members. In order to ensure that both of these goals are met, the Council approved a new Executive Council membership category open to all past presidents and convenors of World Conferences. Under the proposed by-law change, these individuals would be eligible to serve as Council members as long as they remain members of the Society in good standing; they would not need to be elected.

3) improve the election process by requiring candidates for the Executive Council to provide biographical information which will be sent to the membership with the ballot. An informed electorate is best able to select Council members. This amendment is aimed at ensuring that members of the Society have adequate information about all Council candidates.

4) permit by-law revision between General Meetings of the Society.

Under the current by-laws, amendments can only be enacted in connection with a general meeting; general meetings are invariably held in connection with a world conference. But world conferences only take place every three years; it is also possible that world or regional conditions might require cancellation of a world conference. The proposed amendment would permit by-law revision between general meetings in order to ensure that needed changes in the Society's governance structure could be implemented when a general meeting cannot be convened.

The text of these amendments will be circulated to the membership before the next general meeting, and vote will be taken at that meeting.

REPORT OF THE TREASURER:

Greek law 3719/2008 concerning cohabitation between persons of different sex

Law 3719 of 26.11.2008 "on Reform on the law relating to the family, the child, the society and other provisions" regulates, in its first 13 articles, cohabitation between persons of different sex for the first time in Greece.

The above law contains provision for the conclusion and the termination of a cohabitation agreement. The system followed by the Greek law makers is formal. The cohabitation contract is subject to notarial form and enters into force as soon as a copy of the contract is submitted to the registry of the place of residence. The document is filed in a special archive.

Law 3719/2008 also regulates the relations between the cohabitants both during their contract and after its termination, as well as issues regarding their children. More concretely, it grants several rights to the cohabitants, the most remarkable of which are: the possibility of each partner after the termination of their contract to claim a share in the increase of the assets of the other party to the extent he/she has contributed to it, the possibility of one or both parties having to assume the

obligation of maintaining the other one in case his/her inability to maintain himself/herself from his/her own income or property, and certain succession rights. Children born during the cohabitation have all the rights, hereditary and otherwise, of children born to married parents.
