#### **REPORTS ON CONFERENCES:**

Report on ISFL Regional Conference in Israel, June 7-9, 2009.

In June 2009, a three day conference was held in Israel on the subject of Family Law in a Multicultural Environment; Religious Law and Civil Law in Family Matters. There were 65 participants in the conference (and 11 accompanying persons) from more than ten different countries. The opening session was held at Bar Ilan University and included a keynote lecture by Professor Michael Freeman

of University College, London and a speech by Israeli Professor Pinhas Shifman in memory of his former colleague, the late Professor Zeev Falk, one of the founders of the ISFL. ISFL President, Bea Verschraegen, welcomed the participants on Sunday night and also presented a paper in one of the Monday morning sessions. The second day of the conference was held at Sha'arei Mishpat College in Hod Hasharon. The first session featured a panel of experts who spoke about the inter-relationship between secular law and religious law in family matters from the viewpoint of the three main religious communities in Israel: Judaism, Islam and Christianity. The rest of the day was taken up with five further sessions, in each of which there were two parallel panels. The last day of the conference started off with morning sessions at Bar Ilan University. After the closing plenary session and summary given by Professor Lynn Wardle, the participants boarded buses for a trip to Jerusalem. The trip comprised of a fascinating guided tour of the Israeli Supreme Court, which included an address by Justice Salim Jubran, and a short visit to the Brigham Young University Centre on Mount Scopus during which the participants were treated to an organ recital. The final stop was a traditional Israeli restaurant where a tasty supper was enjoyed by all. The participants spoke highly of the standard of the papers and the friendly atmosphere throughout the conference. The Israeli convenors, Dr. Rhona Schuz and Professor Shahar Lifshitz would like to express their gratitude to Professor Lynn Wardle for all the help and guidance he gave in organizing the conference and to the conference committee (Dr. Ayelet Blecher-Prigat, Dr. Binyamin Shmueli, Professor Ruth Halperin-Kaddari and Professor Anna Singer) for all their advice and assistance. Some selected papers from those that are submitted by October 31, 2009 will be published in symposium issues in one of two journals: Family in Law (Sha' arei Mishpat Law College, Israel) and in Journal of Law and Family Studies (University of Utah, USA).

Brazil was home of a Regional Conference of ISFL "Major Rights for Minors - Juridical Protection of The Family, Children and Adolescents" with the support of the Brazilian Institute of Family Law, IBDFAM. Prof. Euclides Benedito de Oliveira, from IBDFAM and Giselle Groeninga, vice-president of ISFL, were the convenors of this Conference. From August 27th to 29th, more than 800 scholars, justices and attorneys discussed children and adolescents' rights in São Paulo - the largest city in Brazil. The conference focused on Child's and Adolescent's Rights, which comprises not only the Juridical Protection of the Family but also the consideration for the child's and the adolescent's peculiarities. The role of the family and the State in taking care of them should be revaluated in times when many variables come into scene: modified family structure, plural families, family disintegration, outsourcing child care, and substitution of parental function in foster and adoptive families. Accusations of sexual and mental abuse are growing in an astonishing rate as a result of a highly permissive society, including sexual issues, modified family frontiers, and enhanced awareness of children's and adolescent's vulnerability. Nevertheless there is an increasing consciousness of adult responsibility in society in general where the Judiciary plays a central role. That was the core of this Regional Conference.

Distinguished members of ISFL – Paulo Lins e Silva, Luis Edson Fachin, Renan Lotufo, José Fernando Simão were some of the lecturers. The honorable presence of Prof. Adriaan van der Linden, from the Netherlands, contributed much to the diffusion of the ISFL in Latin America.

# <u>UPCOMING CONFERENCES AND CALLS FOR PAPERS:</u>

The Future of Family Property in Europe: the 4<sup>th</sup> Conference of the Commission on European Family Law

#### University of Cambridge, 8-10 April 2010

The 4<sup>th</sup> Conference on the Commission on European Family Law, *The Future of Family Property in Europe* will take place at the University of Cambridge from 8 to 10 April 2010. The conference will focus in particular on matrimonial property; pre-nuptial and other agreements relating to family property and finances; and the unification of private international family law.

#### **Conference themes:**

The CEFL is currently drafting **Principles of European Family Law regarding Property Relations between Spouses**. This is the third working field which has been chosen following the successful publication of the Principles regarding *Divorce and Maintenance between Former Spouses* (2004) and *Parental Responsibilities* (2007). Deliberations on the current project will take about another two years since the field of comparative matrimonial property law is highly complex and technical, but initial results of the project will be presented at the conference.

Special attention will also be paid during the conference to the theme of the **autonomy of spouses and cohabitants** to make agreements regulating their property relationships. Do they have binding effect under all circumstances or can the competent authority override, modify or set aside these agreements on account of unfairness or any other ground?

The increasing unification of private international law in family matters pursued by both the Hague Conference on Private International Law and the European Commission will also be discussed.

#### Call for papers:

As at previous conferences, **early career researchers** will have the opportunity to present their research in three parallel working groups on the following topics: (1) protection of the

elderly, (2) freedom of testation and protection of family members, (3) child maintenance. Further information regarding the call and how to submit a paper is available on the conference website: www.cefl2010.org

Expected speakers include the Rt Hon Lord Justice Thorpe, Head of International Family Justice for England and Wales, Professor Elizabeth Cooke, Law Commission for England and Wales, and other distinguished family law academics and practitioners including Professors Katharina Boele-Woelki (the Netherlands), Nina Dethloff (Germany), Marsha Garrison (USA), Cristina González Beilfuss (Spain), Maarit Jänterä-Jareborg (Sweden), and Walter Pintens (Belgium), and Dr Anatol Dutta (Germany).

All interested persons are invited to attend a symposium on The Jurisprudence of the Family: Foundations and Principles in Bratislava, Slovakia, at the Bratislava School of Law, on Friday and Saturday, May 28-29, 2010. The symposium is co-sponsored by the Boston College Law School, by the J. Reuben Clark Law School at Brigham Young University, by the Doha International Institute for Family Studies and Development, and by the Bratislava School of Law. The symposium will feature presentations by nearly thirty (30) leading scholars of family law and jurisprudence from many different regions of the world, representing different traditions of thought and belief, to explore the core principles of jurisprudence that underlie the organization of families and guide the recognition and support of families by society and the legal system of the state. Participants will include prominent academics from universities and scholarly institutes in North America, Western Europe, Central Europe, Eastern Europe, and the Middle East. The purpose of the symposium is to consider: Why is the family the natural and

fundamental unit of society? What are the purposes and structural principles which make families so valuable? Why is the family entitled to the widest possible protection and assistance? What kind of legal protections of the family are needed and effective? What are the duties and purposes and structural principles of society and government which bear on their responsibilities to the family? We seek to enhance the level of understanding of the family's value, and to elevate of the quality of scholarly discourse about family and family law.

#### **Note from Greece:**

#### Presidential Decree 8/6/2009

Recently, in July 2009, in Greece, the Presidential Decree 86/2009 "For the Organization and Functioning of the Institution of Foster Care for Minors" was issued.

This Presidential Decree aims at regulating the issues of the organization and functioning of the institution of foster care for minors in the framework both of the L. 2447/1996, which incorporated the institution of foster care for minors in the Civil Code, and of the social reality of the country. Its main purpose is to serve the public interest, the interest of the minor, and the solution—to the extent that this is possible—of the administrative problems emerging during the enforcement of the

institution of foster care by the agencies in charge. Naturally, the body of the more recent legislation has also been taken into consideration for its drafting.

#### **Note from Norway:**

#### Same-sex marriage in Norway

A comprehensive Marriage Act covering both same-sex and male-female couples, was enacted in Norway in 2008. The act gives lesbians and gay men the right to enter marriage on the same basis as heterosexuals. The bill was enacted into law after long debate in the Parliament, and took effect 1 January 2009. At the same time, an amendment to the Biotechnology Act provides a right for cohabiting and married lesbians to be considered for assisted reproductive technology on the same basis as heterosexual couples. The biological mother's cohabitant/spouse will be granted co-mother status if she has consented to the fertilization, the fertilization has taken place at an approved health-care facility in Norway or abroad, and the semen donor's identity is known, according to the Children Act. An amendment to the Adoption Act makes accommodation for lesbian and gay couples to gain the ability to apply for adoption. The Church of Norway and other recognized faith communities will have the right, though not the obligation, to consecrate marriages. It is up to the Church of Norway to change its consecration liturgy, and until the liturgy is changed, priests in the Church of Norway will not be permitted to perform the marriage of homosexual couples. ### Cohabitants' right to inheritance etc.

In 2008 the Norwegian Parliament enacted a law which gives cohabitants with common children a right to inherit from each other, cf. Chapter III A

of the Inheritance Act. The new law became effective 1 July. 2009. The amount of inheritance is about Norwegian Kroner 280 000 or Euro 32 000 (4 times the basis amount in the national insurance system). More importantly, instead of inheriting, the surviving cohabitant now has the right to remain in possession (so-called *uskifte*) of the joint residence, household goods and a second home which has been used jointly by the cohabitants.
