CALL FOR PAPERS

The International Society of Family Law periodically sponsors a world conference on an important issue in contemporary family law. Recent world conferences were held in Brisbane (2000), Copenhagen and Oslo (2002), Salt Lake City (2005), and Vienna (2008). The 14th world conference, organized in collaboration with the Centre

de droit de la famille, will take place in Lyon, France, on July 19-23, 2011.

The conference theme is: *Intergenerational Obligations*

Today, increasing life expectancy, geographic mobility, and labor-market entry barriers all contribute both to the decline of the traditional family and the rise of new family forms. The traditional extended family is gradually being replaced with smaller family units centered around the parent-child relationship. The new family is also, increasingly, a family that is separated

or blended; it may include only one parent or even a single individual. New family forms and increased individualization of family relationships are fundamental aspects of contemporary life. Although these shifts are diverse and complex, all of them have a profound impact on family function and family law.

The personal and familial obligations recognized by earlier generations are disappearing. New obligations are beginning to appear, redefining intergenerational ties and highlighting, sometimes quite dramatically, the situation of those most at risk, including children, the disabled and, perhaps most of all, the elderly.

These developments raise questions about the respective roles of the family and the state in protecting the needy, as well as the relationship between public and private obligation. These questions are important both for developed countries, which contend with aging populations and economic uncertainty, and for emerging nations confronting the social, demographic, and economic changes produced by modernization.

Conference presentations may focus on economic, demographic, or social issues as well legal policy. International, comparative, and social-science perspectives are all welcome. The conference is open to all family specialists, including specialists from the fields of anthropology, demography, economics, philosophy, psychology, and sociology as well as law. In order to encourage participation in the conference by younger scholars, a limited number of reduced subscriptions university available to iunior lecturers/researchers, doctoral students, and post-doctoral research fellows. FOREIGN NOTES

The Brazilian Institute of Family Law - IBDFAM proposed a Family Statute, composed of 274 articles. A more humanitarian legal system is needed in order to adequately include the plurality of family arrangements present in the Brazilian society, which are not effectively protected by the Present Civil Code. Brazilian society is at the same time conservative and progressive. Although there were several modifications to the original proposal, mainly concerning the homosexual family

composition, the need for major changes in Family Law is now more obvious to a great number of Congressmen. It does not seem that the approval will occur soon, but IBDFAM's aim in discussing issues as common marriage, social parenthood, adoption, family composition, joint custody, children's rights, and so on, was achieved.
