REPORT OF THE PRESIDENT:

I was honoured to be elected as the new President of the Society at our conference in Lyon, France in July. My thanks to my distinguished predecessor, Bea Verschraegen, for all her efforts on behalf of the Society in the last three years.

Prof. Hugues Fulchiron organised an outstanding and highly successful conference on the theme of intergenerational solidarities in Lyon. The concept of 'solidarity' is one which is much more familiar to those from civil law countries than those from common law countries. It speaks of the obligations that family members have to one another. In common law countries, family lawyers are familiar with the idea that spouses may owe obligations to one another after separation and that parents owe obligations to support their children. Much less familiar is the idea that children might have obligations to support elderly parents. This concept is much more familiar to legal systems with a different history and cultural context.

Yet responsibility for the elderly is an issue that all nations around the world need to address. The population in many countries is aging. People are living longer. At the same time, there has been a sharp decline in fertility in the more developed nations of the world – not only in European countries but also in many parts of Asia. That means that, in many countries at least, it may not be realistically possible in future years to expect that the same level of financial support can be given to the elderly from taxpayer funds as is currently the case.

Prof. Fulchiron's choice of topic for the Lyon conference was therefore both timely and insightful. There were many excellent presentations, with a great range of countries represented. It was also good to see so many doctoral students giving papers. We owe Prof. Fulchiron, and his team in Lyon, a great debt of gratitude.

The conference was also a time to pay tribute to some members who have been involved in the leadership of the Society for many years. Marie-Therese Meulders was made an Honorary President of the Society, while a lifetime achievement award was presented to Baroness Ruth Deech. Other lifetime achievement awards, in absentia, were given to Andrew Bainham and Yukiku Matsushima.

The elections to the Executive Council brought a number of new people to the

Council. Members now come from more than 20 nations. The Society continues to make an enormous contribution to the comparative study of family law, and I look forward to leading the Society as it develops further in this role in the next three years.

Report on Sixth Special Commission at the Hague on the Practical Operation of the 1980 Child Abduction Convention and the 1996 Child Protection Convention

We had the privilege of representing the ISFL, which has observer status at meetings of the Hague Conference on Private International Law, at the Sixth Special Commission Meeting on the Practical Operation of the 1980 Child Abduction Convention and the 1996 Child Protection Convention, which took place in June 2011. Due to the large number of issues to be discussed, the meeting was divided into two parts, with the second part scheduled for February 2012. The question of the desirability and feasibility of a protocol to the 1980 Convention will be discussed at the second part of the meeting.

By the time of the Special Commission meeting, there were 85 Contracting States to Abduction Convention and Contracting States to the Child Protection Convention. Since then, Russia has acceded to the Abduction Convention. The meeting began with a presentation of the third statistical survey (prepared by ISFL veteran Professor Nigel Lowe and his associate Victoria Stevens), which is available on the Hague Conference web- site. The survey shows a substantial increase in the number of applications, but a marginally lower number of returns and longer time periods to process applications.

Among other issues, the meeting devoted considerable time to discussing recent jurisprudence of the European Court of Human Rights relating to the Abduction Convention and domestic violence, mediation and direct judicial communication in cases under the Abduction Convention.

At the session on domestic violence, the Deputy Secretary General presented research conducted on behalf of the Permanent Bureau of the Hague Conference into the treatment of domestic violence in abduction cases. This research, which is published on the Hague Conference website, together with the interventions of the delegates show that there is a wide discrepancy between the approach to domestic violence in different jurisdictions. There was wide agreement that there is a need for further work to be undertaken in this area, but a vote on the proposals put by various delegations forward postponed until the second part of the Sixth Commission meeting. It is gratifying that the issue of domestic violence is at last being taken seriously, but, it is of course necessary to ensure that discussions are translated into actions which protect domestic violence victims and their children. either within the framework of a protocol to the Convention (if there will be one) or by other means.

The discussion on the operation of the 1996 Child Protection Convention focused on a review of the excellent draft practical handbook. The examples given in the Handbook illustrate clearly how the Convention works and the advantages which ensue from ratification of this Convention. Members of the ISFL may wish to note the retirement of Professor William Duncan

retirement of Professor William Duncan from his position of Deputy Secretary General of the Hague Conference, as of June 30th 2011. Christopher Bernasconi will be taking his place. Professor Louise Ellen Teitz of the United States joins the Permanent Bureau as First Secretary,

assuming particular responsibility for the Child Abduction and Child Protection Conventions.

And outside the United States, there are markedly increased divorce rates across developed countries—divorce and its effects are a significant social factor in our culture and others. In fact, it might be said that a whole "divorce industry" has been constructed, with divorce lawyers and family counselors, mediators. support groups, etc. As King Henry VIII's divorces showed, divorce has not always been easy or accepted. In some countries, divorce is not permitted and even in Europe, countries such as Spain, Italy, Portugal, and the Republic of Ireland only legalized divorce in the latter quarter of the twentieth century.
