PRESIDENT'S MESSAGE:

Congratulations to Prof. Hugues Fulchiron and his team on the publication of <u>Les solidarités entre générations /Solidarity between generations</u>. This book results from the ISFL World conference in Lyon, France in 2011. I am sure the book will make a lasting contribution to comparative family law research.

One of the themes of the book is caring for elderly family members. This is an issue which is gaining in importance as populations age around the western world. In addition to the population ageing in so many countries, people are also living longer. This is putting ever greater pressure on publicly-funded health and aged care services. Government budgets, already stretched in many countries because of the need to service interest payments on huge levels of public debt, need to accommodate further spending on health and welfare in the next three decades. Many countries with declining birth rates will need to manage the costs of caring for the elderly with a smaller working age population to pay income taxes. The more that care for elderly family members can be made a matter for private familial obligation, the less pressure there will be on public

funds.

However, the implications for family law go beyond the issue of private familial obligation for the elderly. deteriorating situation for public finances around the world, due in part to this 'demographic transition', also has some long-term implications for the family law services that can be offered to workingage parents. In conversations with colleagues in England, New Zealand and elsewhere over the last few months, a recurring theme has been the search by governments to reduce their expenditure on family law. In England this is occurring in particular through severe reductions in the availability of legal aid, and in measures to encourage mediation. In New Zealand also. measures are proposed to reform processes in the Family Court of New Zealand which will reduce reliance on lawyers, some of whom appear at public expense.

While governments are looking for ways to reduce expenditure, the underlying demographic trends in many countries would appear to indicate increasing demand for the resolution of family disputes. At a population-wide level, what drives demand for family law services is separation; and where the parents have

never lived together in the first place, the potential for family law disputes over paternity, child support, and the right to spend time with the child, may begin from birth. As marriage declines as a societal norm, and more couples have children outside marriage, so separation rates are likely to increase. Evidence from many countries indicates that extramarital cohabitation is less stable than marriage, even when there are children.

As family law scholars we need to anticipate these trends in the medium and long-term future. What will family

law look like in an age of scarcity when governments seek alternative ways to meet the demand for family law services while reducing public funding for lawyers and courts? There will be few easy choices. In the ISFL we are well-placed to share experience together on how family law systems can cope best in an age of scarcity while still offering some kind of service to people who are not sufficiently well off to hire private lawyers, and perhaps private arbitrators also.

International Child Abduction (in December

FAMILY LAW, FAMILY COURT, AND FAMILY POLICY IN A CHANGING WORLD

The family law and the family court in Korea have been in the middle of incessant changes, reflecting the transformation in Korean society. Since 2000, important legislative activities have been carried out including abolition of the family-head system, legislation of adult guardianship, and amendment of the adoption law. Moreover, family courts which were previously located only in Seoul have been established across the country in major cities since 2011. All these new systems are of significant importance in terms of family policy.

Changes in family law are not limited within South Korea, but have been taking place all over the world. As such, the Korean Society of Family Law, the Korean Women's Development Institute, and the Seoul Family Court will jointly host a regional conference to take a global perspective on how to evaluate recent changes in family law, family court, and family policy. In addition, the conference will be held as part of commemorating the 50th anniversary of the Seoul Family Court.

The conference will include three workshop sessions: The first session on the function and roles of family courts; the second on family structure, values, and future outlook on family policy; the final on family law, e.g. changes in family law litigations and judicial precedents with international and comparative approaches.

Scholars who wish to present a paper at the conference are asked to submit a short proposal (no more than 300 words) including a working title, institutional affiliation, and contact information of the author(s).
