PRESIDENT'S MESSAGE:

Dear Colleagues in Family Law,

I am deeply honored to be the Society's new President. I look forward to working with you to ensure that the ISFL continues to provide a forum for family law scholars from diverse traditions and with different views to learn from each other.

It was a pleasure to see many of you in Recife, Brazil for the Society's Fifteenth World Conference. Conference organizer Giselle Groeninga, also a Vice President of the Society, did a remarkable job in bringing together more than 200 family law scholars and practitioners from at least twenty countries. Simultaneous English-Portuguese translation was available for all sessions. ensuring that Brazilians and non-Brazilians fully understand each other's could perspectives. If you weren't able to attend, some of the conference papers and PowerPoint slides are available at the ISFL website (www.isflhome.org); two volumes of conference papers, one in English and the other in Portuguese, are also in the works.

While you're looking at the Recife papers, do take the chance to explore the Society's newly redesigned website. Thanks to the initiative and persistence of our immediate past President, Patrick Parkinson, the Society's old, very minimalist internet presence has been replaced with a dynamic

website that will enable us to become far more accessible and efficient. You will already have noticed that the newsletter looks better: it was generated by the new website, which also contains, in the "members-only section," an archive of past issues as well as abstracts of recent Surveys. The new website also offers individualized passwords and password recovery; it will enable members to provide an alternate email address so that we won't lose you; it will generate membershiprenewal notices and offer the possibility of online renewal. For future conferences, it will permit us to register online, and there will be direct links to conference hotels and facilities.

Now that newsletters will be retained in researcher-accessible form, the Executive Council has approved a plan to increase their substantive content. We are hoping that the newsletter will soon - and routinely thereafter - provide news on family law developments around the world. Of course, the newsletter cannot offer the same in-depth treatment of legal issues that the Survey provides. But it could alert members to new iudicial legislation, decisions. policy developments, and research findings. Our hope is to attract a cadre of reporters who will write, yearly, brief summaries of family law news in their regions. These reports will be indexed by key words and topic; they should provide a valuable and durable news source to Society members. If you are interested in serving as a reporter, please contact me or Peg Brinig, our newsletter editor.

The annual Survey has, of course, long provided a durable source of valuable information about family law developments around the world. This year's volume is no exception: Did you know that the Canada Supreme Court has issued a ruling on the constitutionality of a legislative scheme that accords no spousal support rights to unmarried cohabitants? Or that the Japan's Supreme Court has reversed an earlier decision upholding a law giving marital children greater rights than nonmarital children? Or that 68% divorce petitioners in Chongqing, China are female? If you have read the 2014 Survey, these - and a remarkable collection of other family-law facts will already be familiar. If not, time to pull the volume off your shelf and contribute to the general applause for editor Bill Atkin and the authors of 28 essays surveying jurisdictions from Australia to Zimbabwe.

After finishing the Survey, plan ahead! The Society's next World Conference will take place in 2017 in Amsterdam, NL. The conference convener, Professor Masha Antokolskaia (University of Amsterdam) is already working to ensure a stimulating and congenial gathering of family law colleagues.

CONFERENCES AND CALL FOR PAPERS:

Regional Conference Bahamas

The 2nd International Society of Family Law

(ISFL) Caribbean Regional Conference will be held at the British Colonial Hilton Hotel, Nassau, Bahamas, November 19- 21, 2014. The Honourable Madam Justice Desiree Bernard, retired judge of the Caribbean Court of Justice, will speak at the Opening Ceremony on the conference theme, "Our Children, an Endangered Species."

Professor Marsha Garrison of Brooklyn Law School, President of ISFL, will speak on the hot topic of world-wide concern: "Why has the United States failed to ratify the UN Convention on the Rights of the Child?"

The Conference, which commemorates the 25th anniversary of the Convention on the Rights of the Child, is being hosted by the Bahamas Bar Association and is being coordinated by Hazel Thompson- Ahye, member of the Executive Council of the ISFL. President of the Bar Association, Mr. Elsworth Johnson and government officials will deliver addresses at the Opening.

Two other members of the ISFL Executive Council, Professor Dr. Anna Singer and Hazel Thompson-Ahye will be presenting papers. During the conference, Honourable Madame Justice Jacqueline Cornelius of Barbados will speak on the controversial topic of false paternity claims in Barbados, Jamaica and Trinidad and Tobago Courts. Other topics being addressed judges, academics, lawyers psychologists, include, violence against children, local and inter-country adoptions, children in alternative care, levelling the playing field in contested custody cases, access and child maintenance, human embryology and fertilization in the Caribbean context, children's rights in Europe, juvenile rights of disabled children, integrating restorative justice in the Trinidad Family Court, behind the mask of a sexual predator, international child abduction, enforcement of custody and support, and issues of racism and gender.

REPORTS ON RECENT CONFERENCES

WHAT'S NEW?

Argentina has just switched Civil Codes. We now have a new Civil and Commercial Code comprising the whole of Private Law in 2671 articles. Changes in Family law are striking (for us). Remember that Argentina was one of the last countries to legalize divorce (1987) and the first Latin American Country to legalize same sex marriage (2010). Only a year after same sex marriage, a whole revision of the Family Law section was needed, in order to adapt the texts to the gender-neutral paradigm of marriage. What are the most noteworthy changes?

Divorce: We eliminate fault-divorce, as well as the waiting period before divorce is finalized. Interestingly, in order to attribute the common residence to one of the spouses, the judge might consider the interest of the extended family (the legislator thought about several generations, cohabiting under the same roof).

Cohabitation. Paradoxically, given the divorce developments, cohabitants will have to wait a period of two years of exclusive cohabitation in order to produce juridical consequences. Mostly, the regulation tends to protect the mutual residence of cohabitants and it grants alimony to some extent.

Filiation: The paradigm seems to be now that the filiation by ART techniques will be regulated and its treatment occurs before other concepts of biological filiation. Quests for identity-origins are severely restricted. Please bear in mind that Argentina had always emphasized the right of the identity of the child because of cultural issues. Contrary to ART, biological and adoptive filiation are regulated with a strong stress on the biological paradigm and identity rights (i.g. parental contestation actions are easier, plenary adoption might be, to some effects, open).

Spousal relationships: Whilst in the first draft, duties between spouses were eliminated, now they will have more duties than ever. Spouses now owe each other "a common life project, cooperation, moral duty of fidelity, living together, assistance and alimony." As to the effects of the breach of such duties, there are no specific consequences in family law, but many think civil liability might be claimed. We now have prenuptial agreements, and spouses may opt between a regime of separate or community property. They might change their property regime every year (or else, divorce and remarry!).

Parental relationships: We no longer speak of *patria potestas*, nor of parental authority. The new wording is that of "parental responsibility". The status of the stepparent is now recognized and we introduced the delegation of parental responsibility to close kin.

Children's duties. Parents have mostly duties, children have mostly rights. However, they have to collaborate and "comply with their parents' decisions as long as they are not contrary to their superior interests". Children, according to their age, will have also a duty of care towards their parents and other ancestors.

The new Civil Code will come into force in 2016.
